To achieve that mission, our Developer Program enables you to create an innovative profile that makes the CSN platform's best use while honoring members' choice and control over their data. When you develop on the CSN platform, you agree to be bound by the following terms, so please take a few minutes to review the CSN Privacy Policy and API Terms of Use below.

Clinical Social Network (CSN) respects the privacy of our users. This Privacy Policy explains how we collect, use, disclose and safeguard your information when visiting our mobile communication application. Please read this Privacy Policy carefully. IF YOU DISAGREE WITH THIS PRIVACY POLICY'S TERMS, PLEASE DO NOT ACCESS THE APPLICATION.

We reserve the right to amend this Privacy Policy at any time and for any reason. We will alert you about any changes by updating the "Last Updated" date of this Privacy Policy. You are encouraged to review this Privacy Policy to stay informed of updates periodically. You will be considered to have been made aware of, will be subject to, and will be deemed to have accepted the changes in any revised Privacy Policy by your continued use of the Application after the date such revised Privacy Policy is posted.

This Privacy Policy does not apply to the third-party online/mobile store from which you install the Application, including any in-game virtual items, which may also collect and use data about you. We are not responsible for any of the data collected by any such third party.

COLLECTION OF YOUR INFORMATION

We may collect information about you in a variety of ways. The information we may collect via the Application depends on the content and materials you use and includes:

Personal Data

Demographic and other personally identifiable information (such as your name and email address) that you voluntarily give to us when choosing to participate in various activities related to the Application, such as chat, posting messages in comment sections or our forums, liking posts, sending feedback, and responding to surveys. If you choose to share data about yourself via your profile, online chat, or other interactive areas of the Application, please note that all data you disclose in these areas is public. Your data will be accessible to anyone who you authorize to access the Application.

Derivative Data

The information our servers automatically collect when you access the Application, such as your

Financial Data

Personal Information

All personal details that you provide to our Application are safe, private, and secure. We respect the importance of information security and confidentiality and do not disclose them to outside sources.

We do not share your information with third parties, except for verified and secure e-commerce payment providers. Our e-commerce provider handles your personal information and keeps it safe and secure when placing orders; even we cannot access your credit card information. Your personal information (excluding credit card data) is shared with us only for administration purposes.

You can always choose not to provide your details, though they might be needed to purchase or take advantage of some of CSN specific features.

Information Collection and Use

CSN collects personal information to improve how we operate and offer our products and services, communicate with you about those products and services, and provide practical, timely customer support when needed. We may collect the following information from our users:

- First name, last name, email address, billing address, and phone number
- For processing transactions, we also collect either credit card information or bank information, depending on your form of payment, though we do not store any credit card information once your transaction is complete

We also collect Non-Personal information, a term that refers to data that does not identify you.

Social Network

User information from social networking sites, such as [Apple's Game Center, Facebook, If you connect your account to such social networks, Google+ Instagram, Pinterest, Twitter], including your name, social network username, location, gender, birth date, email address, profile picture, and public data for contacts. This information may also include the contact information of anyone you invite to use and join the Application.

Geo-Location Information

We may request access or permission to and track location-based information from your mobile device, either continuously or while using the Application, to provide location-based services. If you wish to change our access or permissions, you may do so in your device's settings.

Mobile Device Access

Mobile Device Data

CSN will collect device information such as your mobile device ID number, model, manufacturer, version of your operating system, phone number, country, location, and any other data.

Push Notifications

We may request to send you push notifications regarding your account or the Application. If you wish to opt-out from receiving these types of communications, you may turn them off in your device's settings.

Third-Party Data

Information from third parties, such as personal information or network friends, if you connect your account to the third party and grant the Application permission to access this information.

Data From Contests, Giveaways, and Surveys

You may provide personal and other information when entering contests or giveaways and or responding to surveys.

USE OF YOUR INFORMATION

Third-Party Service Providers

We may share your information with third parties that perform services for us or on our behalf, including payment processing, data analysis, email delivery, hosting services, customer service, and marketing assistance.

Marketing Communications

With your consent, or with an opportunity for you to withdraw consent, we may share your information with third parties for marketing purposes, as permitted by law.

Interactions with Other Users

Online Postings

Affiliates

We may share your information with our affiliates, in which case we will require those affiliates to honor this Privacy Policy. Affiliates include our parent company and any subsidiaries, joint venture partners, or other companies that we control or are under common control.

Business Partners

We may share your information with our business partners to offer you certain products, services, or promotions.

Offer Wall

The Application may display a third-party-hosted "offer wall." Such an offer wall allows third-party advertisers to offer virtual currency, gifts, or other items to users in return for acceptance and completion of an advertisement offer. Such an offer wall may appear in the Application and be displayed to you based on certain data, such as your geographic area or demographic information. TRACKING TECHNOLOGIES

Cookies and Web Beacons

We may use cookies, web beacons, tracking pixels, and other tracking technologies to help customize the Application and improve your experience. When you access the Application, your personal information is not collected using tracking technology. Most browsers are set to accept cookies by default. You can remove or reject cookies but be aware that such action could affect the availability and functionality of the Application. You may not decline web beacons.
